Presidents Report

Thanks for taking the time to attend our AGM. I'd like to start by thanking our committee members for their input over the past year. Special thanks to our coordinator Sabrina who, as usual, has far exceeded her paid hours on Landcare projects during the year. I'd also like to thank all our Landcare volunteers who turn out whenever they can to help us at our regeneration and revegetation sites, and sometimes the clean-ups as well; and also commend the ongoing great work being done by Friends of Lammermoor and Emu Park Bushcare. It's been a particularly difficult year due to the restriction imposed on us all by the Covid pandemic, and without wishing to jinx us all, I hope we are putting that well and truly behind us as we approach 2021. Despite the setbacks, our sites are looking good at the moment. Alby Wooler Park is looking good and has received many favourable comments. The flowering and fruiting plants on the site attracting a huge number of birds this year, and some mornings the sound was deafening, and to date I have recorded 37 species on the site this year, up from 25 that I recorded in 2017.

We are maintaining the Envirotrail at Yeppoon State School, but the problem with Singapore Daisy on the trail site increases. Complete eradication of this weed is beyond our means; all we can do is regularly spray it to contain its spread until such times as LSC gets serious about eradicating it along the whole creek system.

Our new project on the Farnborough Dunes adjacent to the caravan park continues to be popular with residents and visitors alike. Both areas that we were funded to work on have regenerated well and the bird population has increased, including 6 pairs of nesting Rainbow Bee-eaters observed this year, and a pair of Kookaburras nesting in an old termite nest on a dead tree. Numbers of other bird species has also increased; a great indicator that we are doing things right. We were delighted to receive ongoing funding over the next 3 years to carry on this work begun on this prominent and important site, details of which will be released as we go along.

The project we began on Fig Tree Creek at Braithwaite St has been re-funded and extended to involve residents whose homes back onto the creek. We are having good student involvement in the junior Landcare sessions at Yeppoon State Schools, and we have been in discussion with St Benedict's at Pacific Heights about helping them start a group where we would play the role of advisors only; and we have hosted the girl guides on a couple of site visits where the girls weeded, planted, collected rubbish, and listened to talks about the local environment and its importance. We have also been involved in various beach and island and mangrove clean-up operations in co-ordination with other groups such as Cap Catchments, FBA, Tangaroa Blue and others. There are also projects such Drain Buddies and Cash for Containers that Sabrina can tell you more about.

Involvement with the Lendlease Springboard program, that brings employees of this global company to Yeppoon to work with local environment groups, has been put on hold this year because of Covid. We are hoping that this association will re-commence next year some time. Sabrina and I are also sitting on various committees and community voice groups with LSC and other groups and organizations in the area.

In conclusion, we are working in collaboration with several groups and organizations to make people more aware of the importance of looking after the environment. We have been pleased with the rise in volunteer numbers at our weekly working bees, and the increasingly social aspect of these events. As we say, we are all about working for the community as much as we are about working for the environment.
